Snow Removal Safety

Recently we encountered evidence that residence have been placing snow in the roadway while removing it from their private property. This is dangerous and a violation of State Law.

The law is simple. The Michigan Motor Vehicle Code makes it illegal for you to deposit snow, ice or slush onto any roadway or highway or portion thereof. Furthermore, you may not pile it adjacent to the roadway in such a fashion that it becomes a vision obstruction.

We understand the annoyances and frustrations of snow removal. Safe snow removal practices are everyone's responsibility.

Village Brush Pick-Up

The Village of Pinckney offers bi-monthly brush pick up. Brush removal is the second and fourth Mondays of each month. Please place brush and branches at the curb, cut ends facing the street. Trees and branches can be no larger than 10" in diameter and no longer than 8 feet. No stumps

Replacing incandescent light bulbs with compact fluorescent light bulbs (CFLs) saves energy, money and protects the environment. An extremely small amount of mercury essential for fluorescent light operations is sealed in the CFL glass tubing. Ironically, in Michigan, a regular incandescent light bulb actually releases much more mercury into the environment than a CFL.

A CFL uses up to 75% less energy than an incandescent light bulb and lasts up to 10 times longer.

CFLs also reduce green house gas emissions such as carbon dioxide (CO₂). If every household in Michigan replaced one 75 watt incandescent light with a CFL, it would prevent 624 million pounds of CO₂ from being discharged into the air and save nearly \$40 million dollars every year!

CFL's can be recycled for free at your local Home Depot store Return Desk or through the county's hazardous waste program.

Utility Billing Update

In 2008, the Village conducted a water survey to determine if our rates were in line with our costs. Unfortunately, the research indicated that a large increase in rates was needed to cover the costs.

Instead of doing one large rate increase, the increase has been phased in.

The next increase will take place with the March utility billing which is expected to be in-home the week of April 6.

Please plan for a minimum 3% increase to water rate and water base.

Poverty Exemption from Property Taxes

The general idea of the poverty exemption is to give tax relief to an individual based on their personal circumstance. Factors include meeting federal poverty guidelines and extenuating circumstances such as high medical costs. Applications for exemptions are available at Putnam Township Hall, 3280 West M-36. Snow and the Right-of-Way

One of the major problems each year in winter is damage to rural mailboxes. Most mailbox damage occurs when heavy, wet snow is thrown again a weakened post or box. The Pinckney DPW cannot assume responsibility for such damage. If the mailbox or post is damaged by snow thrown by the snow removal vehicles, it is the homeowners responsibility to replace the box and post.

Additionally, private installations within the public right of way, such as sod, shrubs, sprinkler systems, rocks, etc. maybe damaged in the process of snow removal or seasonal maintenance work. Damage that may occur is not intentional and in many cases unavoidable.

Because it is the statutory responsibility of the DPW to maintain the roadways and right-a-way property, the agency is not held liable or responsible for damage caused to private installations with in the right of way.
