Waste Water Treatment Facility (WWTF) Maintenance: Essential work only, ongoing! Ongoing jetting of all Sewer mains. Rothenberger co. / R.C. Directional boring co. are planning to finish in the spring; the road has been repaired. Ongoing discussion with Reliance co. and VOP engineers have made plans on how to install the wet well for the new pump station #1 and additional financing: the VOP council has rejected the plan asking for additional funds. Daily routine Pump Station readings; weekly and monthly maintenance; sampling lagoons 1 & 2 bi-monthly; as well as all the EGLE MiWater reports that go with. Ongoing cross training of all employees. The VOP has been awarded a SAW Grant from the State which will help with the Sewer Asset management plan. We are using our sewer camera in the bad areas and root cutting when necessary and dealing with asset DMS. Here are the latest WWTF sample results:

Projects:

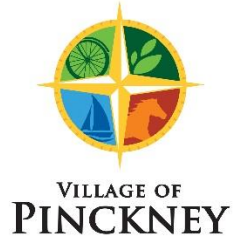

Monthly Report to Village Council March 2020

I'm writing this report from home, so some of the usual information contained in this report is unavailable. As we all know, COVID-19 has changed the way we are living and working. Probably for some time to come. The village has adjusted the schedules of all of the civilian staff, and I was directed to try and limit exposure to the PPD staff. As a result, I have taken Ofc Sloat, who was off with pay, and activated her as part of my 24/7 schedule. Each officer has been placed on a four 12-hour / eight day off rotation. This schedule compresses the officers work period and lengthens their off period, reducing the potential of exposure. It also allows the virus (if infected) time to display symptoms while the officer is off-duty. The theory is that this will help protect the other staff from exposure, as well as the building, since the virus needs 2-14 days to be symptomatic and you are apparently not contagious prior to being symptomatic. This schedule started Sunday, April 5th. It has zero flexibility. If someone gets exposed and needs to be quarantined, we will revert back to a 5-man schedule. I have already built schedules for 5-man, 4-man, 3-man, etc. Sgt Trenkle is aware of how to put this into practice, if I'm unavailable. The current schedule system has been built out to July 11 and has zero double coverage and no required overtime.

Earlier this month we had an exposure scare with Officer Prater. We quarantined him and sent him home for two-days. He has since returned to work without any problems. As a result of this incident, I began talking with the officers about what they would do in the event of a quarantine. Officer Hall mentioned that he would have to live in his car since his mother has a pre-existing condition that would be threatened if he came home to live with her. So as a precaution, I asked Reserve Officer Jesse if I could use his camper as a place to quarantine, at least for the short-term, officers / staff who may become exposed. You'll notice it parked behind the PPD. I my plan is to place the officer there until we can secure better housing later. That housing would most likely be a hotel room. The Holiday Inn Express at the Tanger Outlet Mall has offered rooms for \$50 a night to first responders who need to be quarantined. The cost for that would fall on the village and we would attempt to recover some of that cost via FEMA.

The only activity of note this last month was the arrest of several individuals for credit card fraud and the arrest of the subject involved in the car break-ins we had in January. The credit card fraud arrests came as a result of excellent work by our newest officer Jack Hall. These subjects had tries to use stolen cards at our Marathon several days

prior and were caught on video camera. We had their description and their car. Days later, Jack Hall heard a radio broadcast for a vehicle meeting the description of our attempt and he put that description, with plate information out over the radio. Consequently, a MSP Trooper set up on their expected route home and they were stopped and arrested. Inv Hamlin interviewed them and obtained confessions and we recovered the stolen cards. All three were charged with felony fraud. Inv Hamlin also did exceptional work in locating and identifying the subject involved in the vehicle break-ins. On March 16, 2020 we executed two search warrants and arrested the subject and gained valuable evidence. That investigation is still on-going.
