Re: Request for Agenda Placement and Approval of Marihuana Retailer License Transfer – 759 East Pinconning LLC

Dear Village Leadership:

Our office represents 759 East Pinconning LLC in connection with the Marihuana Retailer License awarded by the Village. We write to formally request consideration of a transfer and alignment of licensure between affiliated entities in a manner that preserves the Village's intent in awarding licenses while promoting efficient and compliant development.

At the outset, we note that our office has been in direct communication with the Village Attorney regarding this matter and the framework under which such a request may be evaluated. We appreciate the Village's willingness to engage in a constructive dialogue.

As the Village is aware, 759 East Pinconning LLC was duly awarded a Marihuana Retailer License pursuant to the Village's competitive application and scoring process. That award reflects the Village's determination that our client satisfied the applicable criteria and is qualified to operate a retailer establishment within the Village. Separately, an affiliated entity, Northville Services and Holdings LLC, has obtained approval for a Class A Marihuana Microbusiness License at the property located at 1268 M-36, Pinckney, Michigan. In light of these parallel approvals, and in the interest of streamlining operations and avoiding duplicative development efforts, as well as meeting the Village's needs of reducing the total number of canna-related licenses in the Village, our client proposes the following:

First, that the Marihuana Retailer License awarded to 759 East Pinconning LLC be transferred or otherwise authorized for use at the 1268 M-36 location.

Second, that upon receipt and finalization of the full transfer of the Retailer License to that location, the affiliated microbusiness license held by Northville Services and Holdings LLC will be voluntarily withdrawn and that the Village reduces the number of allowable micro-licenses in the Village to zero (0) total.

This proposal is intended to consolidate licensure at a single approved location, maintain continuity with the Village's licensing objectives. It is our understanding that this can be done efficiently and without need for additional approvals as the existing, approved site plans for the 1268 M-36 property would remain substantially consistent, thereby minimizing disruption and expediting the timeline for operational readiness.

In order to efficiently move this matter forward, we respectfully request that this item be placed on the agenda for the next available Village Council meeting for consideration and approval. Given the time-sensitive nature of licensing, development, and regulatory compliance, prompt scheduling will allow the parties to proceed without unnecessary delay and in alignment with the Village's established processes.

Our client remains fully committed to complying with all conditions set forth in the Village Council's resolution dated March 11, 2026, as well as all applicable ordinances and regulatory requirements. This request is intended to align existing approvals in a practical and efficient manner that benefits both the applicant and the Village.

We respectfully request confirmation that this matter will be placed on the next available agenda, and we remain available to coordinate with the Village Attorney or administrative staff to ensure that all materials required for consideration are timely submitted.

We appreciate your time and consideration and look forward to continuing our cooperative engagement with the Village.
