To Whom It May Concern,


I hope this message finds you well. I am writing regarding the site plan for For Kids Sake-Trailside at 125 East Unadilla Street, which is set to expire on November 6, 2024, one year following its original approval.

In light of the recent ad-hoc recommendation to the Planning Commission and ultimately the Village Council concerning changes to the ordinance that requires child care facilities to have an on-site playground, I would like to formally request an extension of my current approval. This extension will allow me to submit a revised special land use site plan once the proposed changes are adopted.

Good Afternoon Julie,

I just wanted to touch base with you to make sure that we are on the same page moving forward with regard to the upcoming expiration of the site plan for For Kids' Sake. The site plan expires on 11/6/24 (one year following the original approval). Based on the recommendations by Village Council for changes to the language of the ordinance pertaining to child care facilities and pending review and public hearing by the Planning Commission, I understand that you desire to request an extension of the approval so that when the changes take place, you can submit for a revised special land use and site plan.

We have canceled the upcoming October 7th Planning Commission meeting, however your request for an extension can be heard at the November meeting and still meet any deadlines. In order for that to happen, we need to receive a request from you. If you submit a request to the Planning Commission through me, I can ensure that it is on the agenda for the proper action. The request can simply be to extend the site plan and special land use until such time as the proposed language changes are adopted and enacted.
