RESOLUTION TO AUTHORIZE PLACING A POLICE DEPARTMENT FUNDING MILLAGE PROPOSAL ON THE NOVEMBER BALLOT AND TO APPROVE MILLAGE BALLOT LANGUAGE

WHEREAS, the Village of Pinckney Police Department provides valuable public safety services and programs to the residents of the Village and the public; and

WHEREAS, as authorized by law, Villages may levy a dedicated property tax to finance lawful public services such as those provided by the Police Department; and

WHEREAS, the Village Council of the Village of Pinckney, County of Livingston, State Michigan (the "Village"), determines that it is necessary for the health, safety, and welfare of the Village and its residents to raise funds to continue to provide funding for the Police Department operating and equipment expenses; and

WHEREAS, the Pinckney Village Council seeks to have the voters of the Village determine whether or not they desire to raise funds for the purpose of the operation and equipping of the Village of Pinckney Police Department by adopting an ad valorem property tax levy of **two (2)** mills for a period of five **(5)** years, 2027 through 20**32**, inclusive; and

NOW, THEREFORE, BE IT RESOLVED by the Village Council of the Village of Pinckney, County of Livingston, State of Michigan, that the following proposal be submitted to the qualified voters of the Village of Pinckney at the General Election to be held in the County on Tuesday, November 3, 2026:

PINCKNEY POLICE DEPARTMENT MILLAGE PROPOSAL

For the sole and exclusive purpose of providing funding for operating and equipping the Village of Pinckney Police Department, shall the authorized millage of the Village of Pinckney upon taxable real and tangible personal property within said Village, be increased, and shall the Village be authorized to levy, up to **two (2.0000)** mills **(2.0000)** per \$1,000 of taxable value) for a period of **five (5)** years, 2027 through 20**32**, inclusive.

If approved and levied in full, this millage will raise an estimated **\$198,480** for the Village's Police Department operations and equipment in the first year of the levy based on taxable value. As required by law, a small portion of the millage may also be disbursed to the Pinckney Downtown Development Authority.

BE IT FURTHER RESOLVED that this question is hereby certified to the Village of Pinckney, Township of Putnam, and Livingston County Clerks.

BE IT FURTHER RESOLVED that said proposition shall be stated on the ballots to be prepared and distributed in the manner provided by law.

BE IT FURTHER RESOLVED that all Public Officials of the Village of Pinckney, County of Livingston, State of Michigan, within such time as shall be required by law, are directed to perform all acts which shall be necessary to be performed in order to submit the above stated proposition to the duly qualified voters of said Village at the State General Election to be held on Tuesday, November 3, 2026.

BE IT FURTHER RESOLVED that it is further ordered that a certified copy of this proposition be filed with the Livingston County Clerk and with the Putnam Township Clerk on or before 4:00 p.m., on August 11, 2026.
