RESOLUTION APPROVING THE 2026 L-4029 TAX RATE REQUEST

At a regular meeting of the Village Council of the Village of Pinckney, Livingston County, Michigan, held on May 18, 2026, at 7:00 p.m. at the Village Hall, 220 S. Howell Street, Pinckney, Michigan 48169.

WHEREAS,

the Village of Pinckney is required annually to submit a completed L-4029 Tax Rate Request to the Livingston County Board of Commissioners and County Clerk in accordance with Michigan law; and

WHEREAS,

the Village Council has reviewed the proposed 2026 L-4029 Tax Rate Request reflecting the authorized millage rates and Headlee rollback calculations for the 2026 tax levy year; and

WHEREAS,

the 2026 taxable value for the Village of Pinckney increased from \$107,257,406 to \$111,795,256; and

WHEREAS,

the Headlee rollback has reduced the allowable operating millage from 8.0006 mills to 7.8414 mills and the highway millage from 3.9675 mills to 3.8885 mills as reflected in the submitted L-4029 form; and

WHEREAS,

the Village Council finds it necessary and appropriate to approve the 2026 L-4029 Tax Rate Request as presented.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Village Council of the Village of Pinckney hereby approves the 2026 L-4029 Tax Rate Request as submitted.
2. The following millage rates are authorized for levy in 2026:
 - o Operating Millage: 7.8414 mills
 - o Highway Millage: 3.8885 mills
3. The Village President, Clerk, Treasurer, and any other necessary officials are authorized to sign and submit all required documents associated with the 2026 L-4029 Tax Rate Request to Livingston County and any other appropriate agencies.
