The Tax Increment Financing Plan, which was previously enacted as an Ordinance by the Pinckney Village Council in April 2004, sets forth the theory, benefits and methods of utilizing tax increment financing and bonded indebtedness to finance the necessary capital improvements in order to accomplish the overall goals and objectives set forth in the revised and amended DDA Development Plan.
