- Contractor is responsible for all barricading and traffic control and must conform with MIOSHA standards and Michigan Traffic Control laws.

MAINTENANCE & GURANTEE BOND: The applicant may be required to submit a two-year maintenance and guarantee bond, equal to the estimated cost of the site improvements as established by the fee schedule based on the recommendation of the Village Engineer or qualified agent.
