5) PURCHASE AND RE-BUILD OF BLOWERS

Moma explained the necessity of having two functioning blowers at the wastewater treatment plant and how they keep the system running properly. One of the blowers needs to be replaced. Moma is looking for approval to buy one new blower and one rebuilt blower so he can have three to rotate. Each new blower lasts about eight years, and the re-builds last from four to six years on average.

Motion by Spencer to approve the purchase of two blowers in the amount of \$25,833.55; seconded by Conquest.
