

ORDINANCE NO. 171

ORDINANCE AMENDING THE VILLAGE OF PINCKNEY CODE OF ORDINANCES BY AMENDING TITLE XI, BUSINESS REGULATIONS, CHAPTER 113, MISCELLANEOUS BUSINESSES REQUIRING A LICENSE, §113.33

The Village of Pinckney ordains:

Section 1. The Code of Ordinances of the Village of Pinckney, Title XI, *Business Regulations*, Chapter 113, *Miscellaneous Businesses Requiring a License*, to amend §113.33, entitled *Authorization of Marihuana Establishments*, to read as follows:

§ 113.33 AUTHORIZATION OF MARIHUANA ESTABLISHMENTS.


Except as provided herein and pursuant to the MRTMA, the Village shall authorize the following number of state licensed Marihuana Establishments to operate within its boundaries:


- (A) Marihuana Safety Compliance Facility - one (1) license
- (B) Marihuana Secure Transporter - one (1) license
- (C) Marihuana Microbusiness - one (1) license
- (D) Marihuana Class A Microbusiness - one (1) license
- (E) Marihuana Retailer -one (1) license
- (F) Marihuana Processor - one (1) license
- (G) Marihuana Grower (any class) — one (1) license

Section 2. Repealer Clause. Any ordinances or parts of ordinances in conflict herewith are hereby repealed only to the extent necessary to give this Ordinance full force and effect.

Section 3. Validity and Severability. Should any portion of this Ordinance be found invalid for any reason, such a holding shall not be construed as affecting the validity of the remaining portions of the Ordinance.

Section 4. Effective Date. This Ordinance shall be effective twenty (20) days after its passage, or from and after its publication, whichever is later.


