# Recreational Adult-Use Marihuana Establishments

A marihuana grower facility, marihuana microbusiness, marihuana processor facility, marihuana retailer, marihuana safety compliance facility, marihuana secure transporter facility, or any other type of marihuana-related business licensed by the Marihuana Regulatory Agency.



# Licenses Authorized in Pinckney

- 1 License for MARIHUANA GROWER (any class). A person licensed to cultivate marihuana and sell / transfer to marihuana establishments (Class A: 100 plants; Class B: 500 plants; Class C: 2000 plants).
- 2 Licenses (1 Class A) for MARIHUANA MICROBUSINESS. Licensed to cultivate marihuana plants; process and package marihuana; and sell / transfer to a marihuana safety compliance facility, but not to other marihuana establishments per State Regulation.
- 1 License for MARIHUANA PROCESSOR. A person licensed to obtain marihuana from marihuana establishments; process and package marihuana; and sell / transfer to marihuana establishments.



# Licenses Authorized in Pinckney

1 License for MARIHUANA RETAILER. A person licensed to obtain marihuana from marihuana establishments and to sell / transfer to marihuana establishments and to individuals who are 21 years of age or older.

1 License for MARIHUANA SAFETY COMPLIANCE FACILITY. A person licensed to test marihuana, including certification for potency and the presence of contaminants.


1 License for MARIHUANA SECURE TRANSPORTER. A person licensed to obtain marihuana from marihuana establishments in order to transport marihuana to marihuana establishments.

# Marihuana Establishment Overall Process Overview



- 1. Apply for and receive pre-qualification approval from the State of Michigan if needed
- 2. Apply for and receive a Village of Pinckney Special Use Permit through Zoning Administrator
- 3. Apply for a Village of Pinckney Recreational Adult Use Marihuana Business Provisional License through Village Clerk
- 4. Village to review and approve/deny applications
- Apply for and receive Village of Pinckney Site Plan Approval
- 6. Proceed with construction
- 7. Obtain Certificate of Occupancy
- 8. Apply for and receive Operating License from the State of Michigan
- 9. Apply for final Village of Pinckney Permit



# Special Land Use Permit

### **Application Submittal Requirements**

- ✓ Village application form
- ✓ Processing fee of \$1,700 (\$700 Application fee + \$1,000 escrow)
- ✓ Preliminary site plan containing all the information required per Section 152.389 of the Village Zoning Ordinance
- ✓ Written statement\* explaining how the special land use comply with:
  - The general criteria of Section 152.242 and
  - The specific criteria of Section 152.243 (S)

<sup>\*</sup>Supported by preliminary site plan as applicable



# Special Land Use Permit

### General Approval Criteria of Section 152.242

- Compliance with Village Master Plan
- Compliance with Zoning District
- Compatibility
- Infrastructure and services
- Traffic
- Environmental performance
- Natural resources
- Architecture
- Compliance Required



# Special Land Use Permit

### Specific Approval Criteria of Section 152.243 (S)

- Compliance with prohibited uses
- Pre-qualification approval from the State of Michigan
- Permitted co-location and stacked licenses as applicable
- Permitted hours of operation
- Submittal of a security plan
- Required road frontage and access
- Appropriate separation distance from sensitive land uses
- Proper enclosure and screening
- Adequate environmental performance including odor plan
- Water supply and sanitary sewerage facility impact
- Preliminary sign design
- Compliance with other site development standards

# Village Recreational Adult Use Marihuana Business Provisional License



### **Application Submittal Requirements**

- ✓ Village application form
- ✓ Processing fee of \$5,000 (non-refundable)
- ✓ Village special land use permit
- ✓ Applicant entity articles of incorporation/organization/partnership Agreement
- ✓ Location map with separation distance from sensitive land uses
- ✓ Ownership documentation
- ✓ Preliminary site plan containing all the information required per Section 152.389 of the Village Zoning Ordinance

# Village Recreational Adult Use Marihuana Business Provisional License



### Application Submittal Requirements (Continued)

- ✓ Pre-qualification from the State of Michigan
- ✓ Business Plan
- ✓ Employee training and education plan
- ✓ Facility sanitation plan
- ✓ Security plan
- ✓ Wastewater treatment plan
- ✓ Signed statement of acknowledgment
- ✓ Description of the number and type of jobs created
- ✓ Signatory authorization documentation
