POLICY RESOLUTION 2024-3

**ALLOCATION OF AMERICAN RESCUE PLAN ACT FUNDS FOR CAPITAL  
IMPROVEMENT PROJECTS**

**WHEREAS**, the American Rescue Plan Act (ARPA), pursuant to an Interim Final Rule, with amendments, for the United States Department of Treasury, provides the Village broad latitude to use ARPA funds for the provision of government services to the extent of the reduction in revenue experienced due to the COVID-19 public health emergency; and,

**WHEREAS**, it is the desire of Village Council to utilize a portion of the ARPA funds received by the Village as lost revenue to provide funding for the following capital improvement related projects:

- a. Land acquisition of the Firemen's Park property
- b. Installation of a new well
- c. Purchase and installation of a new server at Village Hall
- d. Upgrade of electronics cabling at Village Hall
- e. Purchase and implementation of BS&A Cemetery module software
- f. Repair of dangerous sidewalks

**WHEREAS**, it is the desire of Village Council to allocate no more than \$220,000.00 of ARPA funding for these projects.

**NOW, THEREFORE, BE IT RESOLVED**, that the Pinckney Village Council decides as follows:

1. The Village will allocate ARPA funds as follows:
  - a. Up to \$18,500 for land acquisition of the Firemen's Park property
  - b. Up to \$100,000 for Installation of a new well
  - c. Up to \$60,000 for purchase and installation of a new server at Village Hall
  - d. Up to \$15,000 for upgrade of electronics cabling at Village Hall.
  - e. Up to \$5,000 for purchase and implementation of BS&A Cemetery module
  - f. Up to \$10,000 for repair of dangerous sidewalks
2. The Village may amend this Resolution to expand, modify, or alter the allocations.

**FURTHER, BE IT RESOLVED** that the Village Council does hereby allocate any remainder of the ARPA funds received to the Major Street Fund to be expended in FY 24/25.
