New Temporary Sign Ordinance

For some time now, the Planning Commission has been working on changes to the Village Sign Ordinance. Under the previous ordinance, temporary signs were prohibited in all districts. This was not something that was actively enforced for various reasons including COVID19, but more importantly, there was an understanding that there is a need for controlled temporary signage and an appropriate ordinance to regulate them. Unfortunately, in many instances, these temporary signs became numerous and a bit out of control.

Under the new ordinance as adopted by Village Council, the following temporary signs are allowed:

- In the CBD, one (1) portable sidewalk sign per ground floor commercial use is allowed, a maximum of four (4) feet high and six (6) square feet per side (12 square feet max for double sided).
- In the Commercial/Office/Research-Technology districts, four (4) signs are allowed per parcel, a maximum of four (4) feet high and six (6) square feet per side (12 square feet max for double sided) – the typical yard sign.
- In all districts, temporary signs:
 - * Shall be on private property only with property owner permission
 - * Shall be non-illuminated
 - * Shall be made of water-resistant materials
 - Shall not be located in a public right-of-way and located and designed to avoid interference with or distraction to vehicular and pedestrian traffic
 - Streamers, flags, etc. or strictly <u>prohibited</u> (This does include the feather flags often seen as "Open", "Now Hiring", etc.)
 - All temporary signs shall be removed when weather conditions create potentially hazardous conditions.

Thank you to everyone who has brought their signage into compliance thus far. Please contact the Zoning Department at Village Hall with any questions.

Downtown Ramp/Sidewalk/Railing Improvements

In February of this year, the DDA Board authorized the expenditure for replacement of sidewalks on the northwest corner of N. Howell Street & E. Main, including the damaged sections of ramp, sidewalk, railing, retaining wall, and meet current ADA accessibility requirements. The Village Engineer and staff have been working with the contractor to finalize the project. A construction schedule should be available in the very near future. Every effort will be made to not disrupt the businesses in the area. Although the ramp at the corner will be temporarily closed, the ramp to the east will remain open.

Two Members added to DDA Board/Planning Commission

As you may be aware, the Planning Commission in the Village acts as the Downtown Development Authority Board which requires members to be electors of the Village. At their April 22nd meeting, the Village Council adopted an ordinance amendment providing for the addition of two non-voting, ad hoc members of the Planning Commission/DDA. The amendment will become effective on May 19th after which President Lavey will nominate two members of the general public for Council confirmation. The purpose of this amendment is to allow two non-residents (business/property owners) to sit on the DDA without changing the current structure.
