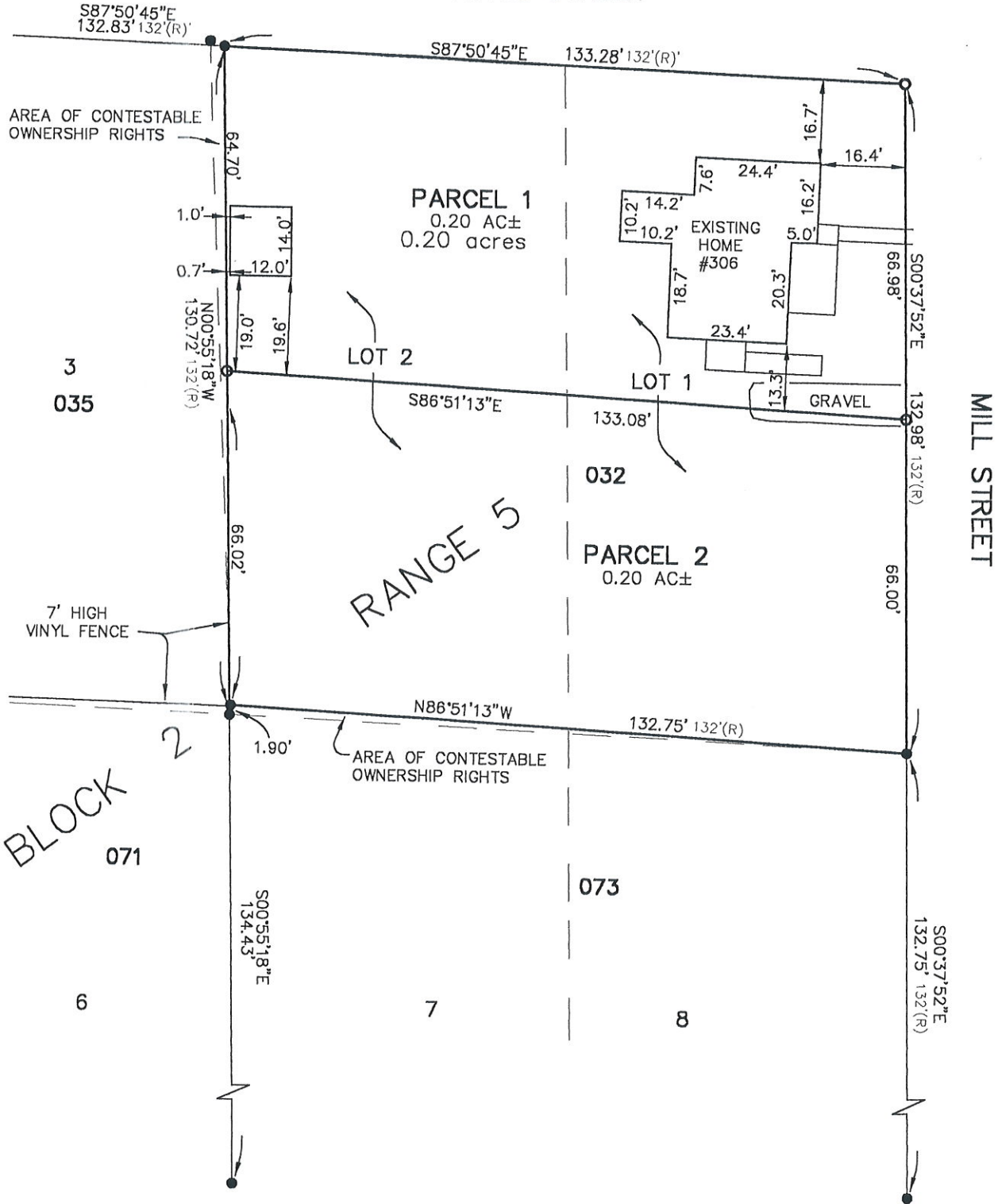



**PARCEL 1 – 0.20 ACRES:**

PART OF LOTS 1 AND 2, BLOCK 2, RANGE 5 OF "THE VILLAGE OF PINCKNEY", ACCORDING TO THE PLAT THEREOF, AS RECORDED IN LIBER 2 OF DEEDS ON PAGE 64 IN THE OFFICE OF THE REGISTER OF DEEDS FOR LIVINGSTON COUNTY, MICHIGAN BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTHEAST CORNER OF SAID LOT 1; THENCE S00°37'52"E 66.98 FEET ALONG THE EASTERLY LINE OF SAID LOT 1; THENCE N86°51'13"W 133.08 FEET; THENCE N00°55'18"W 64.70 FEET TO A POINT ON THE NORTHERLY LINE OF SAID LOT 2; THENCE S87°50'45"E 133.28 FEET ALONG THE NORTHERLY LINE OF SAID LOTS 1 AND 2 TO THE PLACE OF BEGINNING. CONTAINING 0.20 ACRES OF LAND, MORE OR LESS, BEING SUBJECT TO AND TOGETHER WITH THE USE OF EASEMENTS AND RESTRICTIONS OF RECORD, IF ANY.
