

Village of Pinckney Regular Council Meeting Minutes July 8, 2024

President Lavey called the meeting to order in Village Council Chambers at 220 S. Howell, Pinckney, at 7:00 p.m. on July 8, 2024.

CHIEF REPORT: Westland Police will be purchasing our decommissioned cruiser. New AEDs will be purchased through Putnam Fire Dept. as they were the lowest bid. Food Truck Friday suspect has been charged.

PRESIDENT PRO TEM: Motion by Matson to appoint council member Stacy Conquest, second by Lavey. Motion carries in unanimous roll call vote.

LAND DIVISION of 306 MILL: Motion to approve by Buerman, second by Bierman, motion carries in unanimous roll call vote.

TEST WELL BIDS: Two bids received Brown vs. Peerless, with wide price difference. Motion to approve lower Brown bid by Buerman, second by Bierman, motion carries in unanimous roll call vote.

Public Forum opened at 7:25 p.m. Michael Carney expressed concern that the previous Means Project principle had agreed to give unused land east of the building to the village for cemetery expansion, and is longer discussed. Julie Amy suggested that during Food Truck Fridays, the possibility of having kids' games in the closed portion of Main Steet north of the square, to draw attendees over to local businesses on Main Street.
