

Village of Pinckney Regular Council Meeting Minutes June 9, 2025

President Buerman called the meeting to order in Village Council Chambers at 220 S. Howell, Pinckney, at 7:00 p.m. on June 9, 2025.

ROLL CALL:

Present: Bierman, Conquest, Coppersmith, Hochertz, Kane, Self and Buerman Also Present: Stoker (Village Lawyer), Garrison (Chief of Police), Moma (DPW Director), McCall (Village Clerk), Jim Jensen (Putnam Township Village Liaison) and approximately 5 members of the public.

PUBLIC FORUM:

Public forum opened and closed at 7:01 p.m. with no one wishing to speak.

CONSENT AGENDA: Motion to approve by Bierman, Second by Self. Motion passes in a unanimous roll call vote.

PRESIDENT'S REPORT: Buerman stated how well Art in the Park went this year. Mentioned many upcoming events this summer, including Food Truck Fridays, which will have Michigan Lotto in attendance.

POLICE CHIEF REPORT: Garrison detailed their new camera system, and sold the old camera system to offset that cost. Also, two new laptops were purchased with homeland security funds. Garrison also stated that so far this fiscal year, the PPD has returned over 74K to the general fund with the sale of unused/obsolete equipment.

PUTNAM TOWNSHIP REPORT: Jensen stated that Putnam Township is also working on their budget, and mentioned an upcoming Motorcycle Club event in the park.

PUBLIC HEARING: VILLAGE MILLAGE RATE: Open and closed at 7:10 with no one wishing to speak.

NEW BUSINESS:

PPD Speeding Reduction Initiative: Speeding continues to be a problem East bound Unadilla @ Main St. with an average speed of 32mph. This area has received heavier patrolling. Village Millage Rate Resolution 25-11 was discussed and adopted. Motion to adopt by Self, second by Hochertz. Motion passes in a unanimous roll call vote.

DPW Cost recovery ordinance was discussed. Motion to table by Hochertz, seconded by Conquest. Motion passes.

Budget was discussed, with no final decision made.

Motion to go into CLOSED SESSION to discuss a matter with village lawyer by Kane, second by Coppersmith. Unanimous ayes, Closed Session began at 8:05pm. Motion to go back to Open Session by Kane, second by Bierman, unanimous ayes opening back up at 8:56pm.

PUBLIC FORUM opened and closed at 8:57 with no one wishing to speak.
