TRAILSIDE CAFÉ AT THE DEPOT GO-FUND-ME ACCOUNT: Motion to support by Bierman, second by Kane. Motion carries in a unanimous roll call vote.

SPOOKTACULAR TENT PURCHASE OF UP TO \$1500.00: Motion to approve by Bierman, Second by Self. Motion carries in a unanimous roll call vote.
