RESOLUTION TO AMEND THE FEE SCHEDULE FOR WATER AND FIRE SUPPRESSION CONNECTION FEES

WHEREAS, the Village of Pinckney maintains a schedule of fees to recover the cost of providing utility services, including water and fire suppression connections; and

WHEREAS, the Village Council has reviewed the current water and fire suppression connection fees and determined that an increase is warranted to reflect rising infrastructure and operational costs; and

WHEREAS, the Village Council desires to amend the Village Fee Schedule to implement a 5% increase to all applicable connection fees;

NOW, THEREFORE, BE IT RESOLVED, that the Village Council of the Village of Pinckney, Livingston County, Michigan, hereby adopts the following updated fee schedule, effective July 14, 2025:


