FYI - attached is the Existing Conditions Plan where it indicates existing Storm piping sizes. CB02 at the NW corner of the intersection of D19 & E. Hamburg (SE corner of the 'west' lot) indicates a 12" east to CB03 where it increases to a 15" and then an 18" at CB05.

Patrick,

After discussing the storm drain collection system in the area with Mike Hughes and taking a look over your plan (which reduces the overall imperviousness of the site), I see no need to require detention currently at this location.

It should be noted that the outlet for a future detention facility (that you've marked on the plan set pursuant to my request), should the existing parking lot be expanded in the future, would require analysis of the easterly outlet at least down to the intersection of William St. and Hamburg St. We'd want to make sure the pipe had capacity for those flows and deal with any possible connection (we don't know if there is one, but the church was built in the 1960's when such a connection might still have been made) from the old church basement to the storm drain.
