



**Village of Pinckney
Regular Council Meeting Minutes
January 12, 2026**

President Buerman called the meeting to order in Village Council Chambers at 220 S. Howell, Pinckney, at 7:00 p.m. on January 12, 2026.

ROLL CALL:

Present: Bierman, Conquest, Coppersmith, Hochertz, Kane, Self and President Buerman
Also Present: McCall (Village Clerk), D. Moma (DPW Director), PPD Chief Garrison, and approximately twelve members of the public.

OPEN PUBLIC COMMENT at 7:01pm. Tom Chambers, Putnam Township Supervisor, announced an upcoming Spring Cleanup Junk Drive with Unadilla Township and Putnam Township (which includes the village) both participating. Chambers asked Council if they would pay an additional amount of 1/3 towards the cleanup cost. Raymond Rau distributed documents to council, and spoke against having a Village Manager also acting as Zoning Administrator and Village President. Public commenting closed at 7:10pm.

POLICE CHIEF REPORT: Chief Garrison reports that the new officer is on schedule to complete the academy February 20.

POLICE STAFF VACATION CLARIFICATION: A motion to accept with changes by Coppersmith, and a second by Bierman, council unanimously voted in a roll call vote to approve.

DANGEROUS BUILDING ORDINANCE: After discussion, a motion by Hochertz, seconded by Coppersmith, council unanimously voted in a roll call vote to approve.

RESIDENTIAL LAWN PARKING/REAR YARD VEHICLE STORAGE: Ordinance 180. Motion to approve as written by Self, seconded by Coppersmith. Motion passes in a unanimous roll call vote.

UPDATE TO EMPLOYEE CREDIT CARD POLICY: Motion to approve changes by Self, second by Bierman. Motion passed in a unanimous roll call vote.

MOVING COMMUNITY GARDEN TO THE GRASSY AREA BEHIND VILLAGE HALL: After review of the presentation by Greg Strine, Mike Szafranski, and Martina Fenech, motion to move forward by Hochertz, seconded by Bierman. Motion passes in a unanimous roll call vote.

DPW DIRECTOR AS ACT 51 COORDINATOR: Motion by Coppersmith, seconded by Bierman, council unanimously voted in a roll call vote to approve.

CHIEF OF POLICE AS SPECIAL EVENTS OPERATIONS COORDINATOR: motion by Hochertz, seconded by Self, council unanimously voted in a roll call vote to approve.

CHANGING VILLAGE OFFICE HOURS TO MONDAY THROUGH THURSDAY 8AM TO 5PM: Motion to approve by Bierman, second by Conquest. Motion passes in a unanimous roll call vote.

PUBLIC FORUM opened at 8:27 Julie Amy spoke in support of the character of the current Village President. Public forum closed at 8:33pm.
