**RESOLUTION APPROVING PAY ADJUSTMENTS FOR THE  
VILLAGE OF PINCKNEY POLICE DEPARTMENT\*\***

**WHEREAS**, the Village of Pinckney seeks to retain qualified law enforcement personnel and maintain competitive compensation for police staff; and

**WHEREAS**, the Village Council has reviewed current compensation levels for the Village of Pinckney Police Department and finds it necessary and appropriate to approve wage adjustments;

**NOW, THEREFORE, BE IT RESOLVED** by the Village Council of the Village of Pinckney, Livingston County, Michigan, that the following compensation adjustments are hereby approved:

1. **Police Chief – Jeff Garrison**
  - Compensation shall be set at **ten percent (10%) higher than the salary of the Village of Pinckney Police Sergeant**, effective **February 9, 2026**.
2. **Sergeant – Mike Trenkle**
  - Compensation shall be set at **twenty-one percent (20%) higher than the highest-paid Village of Pinckney police officer**, effective **February 9, 2026**.
3. **Part-Time Police Officers**
  - Compensation shall be set at **\$25.00 per hour**, effective **February 9, 2026**.

**BE IT FURTHER RESOLVED**, that the Village President and Village Clerk are authorized to take all actions necessary to implement this resolution and ensure compliance with applicable laws, ordinances, and budgetary requirements.

**BE IT FURTHER RESOLVED**, that this resolution shall take effect immediately upon adoption, with compensation changes applied according to the effective dates stated herein.
